## Potential health effects

## Primary routes of exposure:

## 4. First-Aid Measures

#### General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. If person is not breathing, call 911 or ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or physician for treatment advice. #### If inhaled:

## Note to physician

Treatment:

Treat according to symptoms (decontamination, vital functions), no known specific antidote. Aspiration of this product during induced emesis can result in lung injury. If evacuation of stomach contents is considered necessary, use method least likely to cause aspiration, such as gastric lavage after endotracheal intubation.

## 6. Accidental release measures
